The North Texas community is invited to submit art to the *2008 FWCAC Biennial*. The *Biennial* is an open exhibit and accepts all submitted artwork. All artwork delivered to the FWCAC over a 3-day period is displayed on a first-come, first-served basis. Art is hung salon-style.

At the Fort Worth Community Arts Center, we celebrate our community's diversity through the arts, and showcase the talents of regional artists. The *Biennial* was the first exhibition at the Fort Worth Community Arts Center, under the title ***The 39-Hour Show***. In 2004, the exhibition became a biennial in even-numbered years.

Sight & Sound is the first ever party at the FWCAC that is dedicated to raising money for the FWCAC. Monies raised will be used for theatre equipment, better lighting in the galleries, new signage and other improvements that will make the Fort Worth Community Arts Center the premier place for the arts in Fort Worth.

The **Texas Artists Coalition** (TAC) is a membership program for artists, offering workshops and services to help artists move forward in their careers. Basic membership is \$50 annually, Sustaining is \$100 annually.

ELIGIBILITY & MEDIA

All members of the North Texas community are eligible to enter regardless of age or experience. One original artwork per artist. Artwork must not exceed 36" in any direction, including framing, but excluding pedestal. All media in 2D & 3D accepted; 2D work must be suitably framed and have all hardware ready for hanging. 3D artists should bring their own pedestals. Video may be displayed if artist supplies all equipment including power cords. Total size of equipment must not exceed 36".

ENTRY FEE

\$10 per person. \$5 for TAC members. Exhibitors will receive a coupon for \$5 off the cost of a ticket for **Sight & Sound**, the 2008 FWCAC party on March 8, 2008. Tickets are \$25 in advance or \$35 at door.

SALES

Artwork may be for sale. Artists receive 80% of sale of their artwork. Funds from exhibit will be used to support continuing exhibitions at the Fort Worth Community Arts Center.

INSURANCE & LIABILITY

Artwork exhibited in the FWCAC will be given great care. Unless the artist wishes to provide his/her own insurance coverage, the FWCAC insures all exhibitions under its existing insurance policy, which covers up to \$500,000, against all risks of physical loss or damage while on the premises during the period of the exhibition. If the exhibitor wishes to provide his/her own insurance, such actions constitute the release of the FWCAC from any liability in connection with the exhibition.
